Q1'13 Completes Mega M&As, with Transaction Value Hitting Record High

The latest data of Zero2IPO Research Center, a famous VC & PE research institution in Greater China Region, show that 204 investment deals occurred in China's VC/PE market in Q1'13, a YoY decrease of 6.0% and a QoQ decrease of 29.2%; the number of deals with the amount disclosed was 185 and the total trading value involved amounted to US\$31.26B, up 86.1% significantly YoY and as high as 173.7% QoQ, hitting a record high in M&A value in a single quarter in China's VC/PE market. 177 M&As were domestic ones with an aggregate trading value of US\$4.92B, 18 outbound ones with an amount of US\$16.65B and nine inbound ones involving US\$9.69B.

Didi Taxi and Call-Taxi Receive US\$10M Investment Respectively

Insider confirmed to Bianews that Didi Taxi had received a new round of investment from Tencent. The investment amount was about US\$10.00M. News had spread that Tencent intended to invest in Didi Taxi in this March. Currently, this news is confirmed from more than one sources.

Another financing was about Call-Taxi, under the flag of Yongche.com, a car-sharing Internet car service platform. Person with investment bank told the parent company Yongche.com had obtained more than US\$15M worth series B investment from CBC Capital founded by Edward Tian. The investment will boost the development of its branch Call-Taxi in a large scale.

Alibaba Increases Its Shareholding Ratio in DDcoupon

According to insider, Alibaba increased its shareholding ratio in DDcoupon and became the second largest investor only second to F&H. The total investment amount has not been disclosed yet and shareholding ratio is unknown.

Data show that DDcoupon received series A investment from Morningside Ventures in 2005, series B investment from Morningside Ventures and Korean KTB in 2008, series C investment of US\$9M from Morningside Ventures and HTC Corporation Direct Investment Department in 2010, and series D financing of US\$40M from F&H and CID Group in April 2012. Alibaba participated in series E investment of DDcoupon in October 2012. This is series F financing of DDcoupon and the additional investment of Alibaba.
