

2. The principal Law is hereby amended by the insertion therein immediately after section 22, of the following new section:—

insertion of new section 22 in the principal Law.

22A.—(1) When a mukhtar is unable or unwilling to neglect or refuse to perform any of the duties or any of the acts imposed upon mukhtars by this Law, the Commissioner may perform the said duties or do the said acts himself or may appoint a fit person to perform the said duties or to do the said acts, and the duties and acts performed or done under this Law by the Commissioner or by the person so appointed shall be valid and effective as if performed or done by the mukhtar.

(2) The provisions of this section may be invoked in addition to or in lieu of any other action which may be taken under this or any other Law in force for the time being in force in respect of any default in the performance of the duties under this Law.

A LAW TO AMEND THE ADMINISTRATION OF ESTATES LAW, 1954. **43 of 1954**

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows:—

1. This Law may be cited as the Administration of Estates (Amendment) Law, 1958, and shall be read as one with the Administration of Estates Law, 1954 (hereinafter referred to as "the principal Law") and the principal Law and this Law may together be cited as the Administration of Estates Laws, 1954 and 1958.
