#### IRRIGATION DIVISION OF CHAKISTRA.

##### *Rules.*

These rules may be cited as the Irrigation Division of Chakistra (Amendment) Rules, 1952, and shall be read as one with the Irrigation Division of Chakistra Rules, 1947 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Irrigation Division of Chakistra Rules, 1947 to 1952.

#### THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAW, 1949.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Law, 1949, the following Rules made by the Committee of the Irrigation Association of Kambi Pharmaka ("Milades" Water), in the District of Nicosia, are published in the *Gazette*.

#### IRRIGATION ASSOCIATION OF KAMBI PHARMAKA ("MILADES" WATER).

##### *Rules.*

1. These rules may be cited as the Irrigation Association of Kambi Pharmaka ("Milades" Water) Rules, 1952.

2. In these rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Nicosia;

"Committee" means the Committee of the Irrigation Association;

"Irrigation Association" means the Irrigation Association of Kambi Pharmaka ("Milades" Water);

"Law" means the Irrigation (Private Water) Association Law, 1949;

"List" means the list of the names and residences of the proprietors and of the extent of the interest of each proprietor in the water, as finally settled in accordance with the provisions of section 11 of the Law;

"Water" means the water commonly known as "Milades" Water;

"Works" means the irrigation works of the Irrigation Association.
