THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAWS, 1950.

ORDER MADE UNDER SECTION 22 (a) (i).

Authority to the Improvement Board of Ayia Phyla to contract a loan.

In exercise of the powers vested in me by section 22 (a) (i) of the Villages (Administration and Improvement) Laws, 1950, I, the Colonial Secretary, do hereby order as follows :—

1. The Improvement Board of Ayia Phyla (hereinafter referred to as "the Board") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lenders") a sum not exceeding one thousand pounds (£1,000) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say :—

- (a) the sum borrowed shall be repayable by the Board to the Lenders in ten equal annual instalments (comprising sinking fund and interest);
- (b) the sum borrowed shall be utilized by the Board for the re-conditioning and asphaltting of the principal village streets.

2. For the purpose of securing the repayment of the sum under the loan, the Board shall, subject to any prior mortgage thereon, mortgage to the Lenders all the rates, fees, rents, tolls or charges now payable or hereafter to become payable to the Board.

THE TREE PLANTING (VILLAGE AREAS) LAW.

CAP. 175.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Ghaziveran in the District of Nicosia, on the 20th day of July, 1952, under the provisions of the Tree Planting (Village Areas) Law, Cap. 175, it was determined by the requisite majority of the owners present thereat that a certain area should be reserved as the Tree Planting Area of the said village of Ghaziveran;

And whereas the Mukhtar of the said village of Ghaziveran has forwarded to me a report signed and sealed by him containing a description of the area in question with boundaries and particulars and stating that such area fulfils the conditions prescribed in section 10 (4) of the said Law:

Now, therefore, I, the Commissioner of the District of Nicosia, having approved the said report, do by this order declare that the area described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Ghaziveran.

The area lying within the following boundaries, that is to say :—

The boundary commences at the most northern point of plot No. 16 of the Government Survey Plan No. XIX.45, locality "Livadhia" and proceeds north-eastwards, south-eastwards and south-westwards along the
