

No. 338.**THE AGRICULTURAL PRODUCE EXPORT REGULATIONS, 1953.****NOTICE UNDER REGULATION 14 (b).**

In exercise of the powers vested in me by regulation 14 (b) of the Agricultural Produce Export Regulations, 1953, I, the Acting Director of Agriculture, hereby direct that until further notice :—

(1) Onions intended for export to ports other than the Mediterranean ports, Aden and Port Sudan shall be of the Grade "Selected" or "Picklers" as prescribed in the Fourth Appendix, Part IV, regulations 2 and 4, of the Agricultural Produce Export Regulations, 1953, and packed in one of the following manners :—

(a) In well ventilated cases or crates of wood the construction and dimensions of which shall be approved by the Produce Inspector ; or

(b) In new open mesh bags the contents of which shall not exceed 20 okes (56 lb.) net.

(2) Onions intended for export to Mediterranean ports, Aden and Port Sudan shall be of the grades "Selected", "Commercial" or "Picklers" as prescribed in the Fourth Appendix, Part IV, regulations 2, 3 and 4 of the Agricultural Produce Export Regulations, 1953, and should be packed in one of the following manners :—

(a) In well ventilated cases or crates of wood the construction and dimensions of which shall be approved by the Produce Inspector ; or

(b) In new open mesh bags the contents of which must not exceed 40 okes (112 lb.) net.

(3) Onion sets intended for export to ports other than the Mediterranean ports, Aden and Port Sudan shall be packed in accordance with the provisions governing the packing of Onions to the same ports (regulation 1 (a) and 1 (b) above).

No. 339. THE MUNICIPAL CORPORATIONS LAW.

CAP. 252 AND LAWS 11 OF 1950, 31 OF 1951 AND 20 OF 1953.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF PAPHOS.

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Paphos hereby make the following bye-laws :—

1. These bye-laws may be cited as the Paphos Municipal (Amendment No. 4) Bye-laws, 1953, and shall be read as one with the Paphos Municipal Bye-laws, 1943 to (No. 3) 1953 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Paphos Municipal Bye-laws, 1943 to (No. 4) 1953.

2. Paragraph (1) of bye-law 92 of the principal Bye-laws (as set out in the Paphos Municipal (Amendment) Bye-laws, 1952) is hereby deleted and the following paragraph substituted therefor :—

"(1) All places situated within the municipal limits and lying between the following boundaries, that is to say, Fellahoglou Street upto Diplar-kadja along both sides of the two by-ways of the road leading to Diplar-kadja, thence along Athina Street and that portion of Thermopilon Street, between the end of Alexandrou Street and in front of the premises of St. Neofidos, and thence upto the junction of Fellahoglou Street, are hereby provided as public fair markets during the day or time that any fair is being held, within the municipal limits."

The above bye-laws have been approved by His Excellency the Acting Governor.
