No. 615. THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.

CAP. 311 AND LAWS 28 OF 1951 AND 12 OF 1952.

BYE-LAWS MADE BY THE WATER COMMISSION OF KORPHI VILLAGE (LIMASSOL DISTRICT) UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Korphi village, in the District of Limassol, hereby make the following bye-laws:—

1. These bye-laws may be cited as the Village Domestic Water Supply (Korphi) Bye-laws, 1953.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this bye-law, the Village Domestic Water Supply (Elea) Bye-Laws, 1950, published in the *Gazette* of 1st November, 1950, shall:—

(a) be deemed to be bye-laws made by the Water Commission of Korphi and to be incorporated herein, and

(b) apply to the village of Korphi.

(2) The bye-laws set out in Part I of the Schedule hereto shall be substituted for the corresponding bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950.

(3) Those bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950, mentioned in Part II of the Schedule hereto, shall not apply to the village of Korphi.

SCHEDULE.**PART I.**

(Bye-law 2 (2).)

BYE-LAWS TO BE SUBSTITUTED.

Bye-law 2.—In these bye-laws, unless the context otherwise requires—

“Commissioner” means the Commissioner of the District of Limassol and includes an Assistant Commissioner of that District;
