

COMPULSORY ACQUISITION ORDER.
THE ANTIQUITIES LAW (CAP. 43)—Section 12
AND
THE LAND ACQUISITION LAW (CAP. 233).

Cap. 43. Whereas His Excellency the Governor is satisfied that in order to preserve the amenities of the Bedestan, the Ancient Monument set out in the Second Schedule to the Antiquities Law as item 11 of the Nicosia District it is desirable that no building should be erected in the proximity of the said ancient monument upon the plot of land described in the Schedule hereto and that any buildings thereon should be demolished:

Now, therefore, in exercise of the powers vested in him by section 12 of the Antiquities Law, His Excellency the Governor is pleased to direct and hereby directs that the properties described in the Schedule hereto be acquired on payment of such amount by way of compensation as may be agreed upon between the Commissioner of Nicosia and Kyrenia and the proprietors thereof and that in default of agreement within one month from the date hereof the amount of compensation be determined in accordance with the provisions of the Land Acquisition Law.
