

# No. 280. THE PUBLIC HEALTH (VILLAGES) LAW.

## CAP. 142.

The following rules made by the Village Health Commission of Nikos, in the District of Nicosia, and approved by the Commissioner are published in the *Gazette*.

### RULES MADE BY THE VILLAGE HEALTH COMMISSION OF NIKOS UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, Cap. 142, the Village Health Commission of Nikos hereby make the following rules :—

1. These rules may be cited as the Village Health (Nikos) (Amendment) Rules, 1954, and shall be read as one with the Village Health (Nikos) Rules, 1952 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Nikos) Rules, 1952 and 1954. *Gazette : Supplement No. 3: 19.11.1952.*

2. The following rules shall be substituted for Rules 19 and 31, respectively, of the principal Rules :—

"Rule 19. The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say :—

# No. 281. THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.

## CAP. 311 AND LAWS 28 OF 1951 AND 12 OF 1952.

### BYE-LAWS MADE BY THE WATER COMMISSION OF KARAKOUMI VILLAGE (KYRENIA DISTRICT) UNDER SECTION 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Karakoumi village, in the District of Kyrenia, hereby make the following bye-laws:—

1. These bye-laws may be cited as the Village Domestic Water Supply (Karakoumi) Bye-laws, 1954.

2.—(1) Subject to the provisions of paragraphs (2) and (3) of this bye-law, the Village Domestic Water Supply (Elea) Bye-laws, 1950, published in the *Gazette* of 1st November, 1950, shall—

- (a) be deemed to be bye-laws made by the Water Commission of Karakoumi and to be incorporated herein, and
- (b) apply to the village of Karakoumi.

(2) The bye-laws set out in Part I of the Schedule hereto shall be substituted for the corresponding bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950.

(3) Those bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950, mentioned in Part II of the Schedule hereto, shall not apply to the village of Karakoumi.
