THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAW, 1949,
AND
THE IRRIGATION ASSOCIATION OF PALEKHORI ORINIS
(" PANO MAROULLENA " WATER) RULES, 1952.

DISSOLUTION OF THE IRRIGATION ASSOCIATION OF PALEKHORI ORINIS (" PANO MAROULLENA " WATER).

Whereas an application was made to the Commissioner of Nicosia signed by not less than two-thirds of the proprietors requesting that the Irrigation Association of Palekhori Orinis (" Pano Maroullena " Water) (hereinafter referred to as " the Association ") be dissolved ;

And whereas at a meeting of the proprietors of the Association held under Rule 18 of the Irrigation Association of Palekhori Orinis (" Pano Maroullena " Water) Rules, 1952 (hereinafter referred to as " the Rules ") at the village of Palekhori Orinis on the 27th June, 1954, it was decided by the requisite majority of the voters present thereat that the said Irrigation Association should be dissolved :

Now, therefore, it is hereby notified that the Association has been dissolved accordingly as from the 27th June, 1954, subject to the reservations and exceptions contained in the Rules.
