(2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Nikos) Rules, 1952.

(3) Those rules of the Village Health (Nikos) Rules, 1952, mentioned in Part II of the Schedule hereto, shall not apply to the village of Vavla.

No. 57. THE PUBLIC HEALTH (VILLAGES) LAW. CAP. 142.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF ODHOU IN THE DISTRICT OF LARNACA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Law, the Village Health Commission of Odhou hereby make the following rules :—

1. These rules may be cited as the Village Health (Odhou) Rules, 1955, and shall come into operation on their publication in the *Gazette*.
