#### THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAWS, 1950 AND 1953.

##### BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF AYIOS AMVROSIOS.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Ayios Amvrosios make the following bye-laws :—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Ayios Amvrosios (Amendment) Bye-laws, 1955, and shall be read as one with the Villages (Administration and Improvement) Ayios Amvrosios Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be
