

No. 418. THE SOIL CONSERVATION LAW, 1952.

NOTICE UNDER SECTION 9.

Pursuant to section 9 of the Soil Conservation Law, 1952, it is hereby notified that, with the approval of the Governor, a Soil Conservation Division has been formed in respect of the area lying within the following boundaries that is to say :—

The boundary commences at the most western point of plot No. 339 of the Government Survey Plan No. XXIII.10, Psilatos village, locality "Kamila", and proceeds in a northerly and easterly direction and including the said plot, plots Nos. 340 (part), 335 (part) and 336 of the said plan, plots Nos. 30 (part), 9, 27, 26, 96.4, 78, 75 and 96.7 of the Government Survey Plan No. XXIII.11, Psilatos village, plots Nos. 103, 104, 105 and 141 of the said plan, Lefkoniko village, to the north-eastern corner of the last mentioned plot ; thence southwards along the boundaries of and including the last mentioned plot, plots Nos. 140, 139, 136 (part), 123, 125, 126 and 127 of the said plan, Lefkoniko village, plots Nos. 469, 468 and 461 (part) of the said plan, Yenagra village, to the south-eastern corner of plot No. 482 of the said plan, Yenagra village ; thence westwards along the boundaries of and including the last mentioned plot, plots Nos. 478, 487 and 488 (part) of the said plan, Yenagra village, to the north-western corner of the last mentioned plot, of the said plan, Yenagra village, which corner is a track leading from the village of Yenagra to the village of Psilatos ; thence northwards along the said track to the north-western corner of plot No. 52 of the said plan, Psilatos village ; thence westwards along the boundaries of and including plots Nos. 536 and 530 (part) of the said plan, Yenagra village, to the north-western corner of the last mentioned plot, which corner is on a track leading from the village of Yenagra to the village of Psilatos ; thence north-westwards along the said track to the point of commencement, all which said area is shown edged in red on the Government Survey Plan signed by the Director of Agriculture and deposited in his Office at Nicosia.

And that the Soil Conservation Scheme briefly set out in the Appendix hereto will be in operation within the aforesaid area.

APPENDIX.

Ten spillways with wing walls and embankment bunding will be constructed ; an existing spillway known as that of "Velousi" will be improved. The river beds will be filled in and levelled and converted into arable land, while the high ground which cannot be reached by the water will be scraped. Irrigation channels will be provided from each spillway for irrigation purposes whenever this is necessary.

The total cost of the scheme has been estimated at approximately £8,200.
