

No. 527. THE EXCHANGE CONTROL LAWS, 1952 AND 1954.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTIONS 7, 25 AND 33.

In exercise of the powers vested in me by Sections 7, 25 and 33 of the Exchange Control Laws, 1952 and 1954, I, the Financial Secretary, hereby order as follows :—

1. This Order may be cited as the Exchange Control (Payments) (Amendment No. 2), Order, 1955, and shall be read as one with the Exchange Control (Payments) Orders, 1954 to 1955 (hereinfter referred to as “ the principal Order ”), and the principal Order and this Order may together be cited as the Exchange Control (Payments) Orders, 1954 to (No. 2) 1955.

2. The principal Order is hereby amended—

(a) by adding at the end of clause 6 thereof the following paragraph:—

“(1) ‘ Italian Monetary Area ’ means the Italian Republic, the Republic of San Marino, the territory of Somaliland under Italian Administration and the portion of the Former Free Territory of Trieste now under Italian Administration ;” ;

(b) by inserting in the Third Schedule after item 4 thereof in the first column the words and figures “ 4A. Italian Monetary Area ” and in the second column—

“(a) Payment in sterling from a Transferable Account of a person resident in a Transferable Account territory ;

(b) Payment in sterling from an account of a person resident in any territory specified in the First Schedule to this Order ;

(c) Payment in Italian Lire.”

3. This Order shall be deemed to have been made and to have come into force on the 22nd day of August, 1955.

EXPLANATORY NOTE.

(This Note is not part of the Order, but is intended to indicate its general purport).

This Order amends the Exchange Control (Payments) Orders, 1954 to 1955, by extending the prescribed manner of payment for exports from Cyprus to the Italian Monetary Area.

No. 528.**THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND CONTROL) LAW, CAP. 157.****NOTICE UNDER SECTION 12.**

In exercise of the powers vested in me by Section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that during the period between the 10th September, 1955, and the 10th October, 1955, flocks within the area of Angolemi village, Nicosia District, shall, between the hours of sunset and sunrise, be kept inside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock, under the proper charge of a licensed shepherd, from one village area to another, along any public road, at any hour.
