In exercise of the powers vested in him by sections 2 and 3 of the Game and Wild Birds Protection Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to prescribe that the periods specified in the Schedule hereto shall be a close season in addition to the close season as defined in section 2 of the Law.

SCHEDULE.

1. The period between the 1st day of October, 1955, and 29th day of October, 1955, both days inclusive.
2. The period between the 16th day of January, 1955, and 31st day of January, 1956, both days inclusive.
3. All days in the week during a non-close season except Wednesdays and Sundays, and the 24th, 26th and 31st December, 1955, and the 7th day of January, 1956.

11 of 1953. In exercise of the powers vested in him by section 2 of the Diplomatic Privileges (Extension) Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

This Order may be cited as the Diplomatic Privileges (International Civil Aviation Organization) (Amendment) Order, 1955, and shall be read as one with the Diplomatic Privileges (International Civil Aviation Organization) Order, 1949 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Diplomatic Privileges (International Civil Aviation Organization) Orders, 1949 and 1955.

2. Paragraph (1) of Article 9 of the principal Order is hereby amended by the substitution for the words "to the Council of the Organization" (line 3) of the words "to the Assembly or to the Council of the Organization, to any Commission (however named) provided for in the constitution of the Organization, or to any Committee of such Assembly, Council or Commission".

3. This Order shall be deemed to have come into operation on the 4th day of November, 1954.
