1. This Order may be cited as the Curfews (Limassol District No. 19) Order, 1955.

2. No person within the Municipal boundaries of the town of Limassol shall be out of doors on the dates and during the hours prescribed in the Schedule hereto except under the written authority of the Commissioner of Limassol, or the Senior Superintendent of Police, Limassol :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 25th day of October, 1955.
