1. This Order may be cited as the Unlawful Association (A.K.E.L.) Order, 1955.

2. The organization commonly known as "A.K.E.L." ("Reform Party of the Working People") is hereby declared to be used for the promotion of disorder and of the spread of sedition within the Colony and to be proscribed within the Colony.

3. This Order shall remain in force for a period of twelve months from the date of its publication in the *Gazette* and no longer unless renewed for such period or periods, not exceeding twelve months at any one time, as the Governor-in-Council may direct by order published in the *Gazette*.

3. This Order shall remain in force for a period of twelve months from the date of its publication in the *Gazette* and no longer unless renewed for such period or periods, not exceeding twelve months at any one time, as the Governor-in-Council may direct by order published in the *Gazette*.
