THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 8) 1956.

ORDER MADE UNDER REGULATION 34 (1) (b).

In exercise of the powers vested in the Governor under Regulation 34 (1) (b) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 8) 1956, and delegated to me by Notification No. 807 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1955, I, the Commissioner of Limassol, hereby prohibit the use of all vehicles within the area of Limassol District described in the Schedule hereto from 5th July, 1956, until further notice:

Provided that the use of vehicles will be allowed between the hours of 4 a.m. to 6 a.m. and 5 p.m. to 7 p.m. daily from 6th July, 1956.

SCHEDULE.

*Description of Area.*

Karvounas cross roads along Limassol-Nicosia District boundary to the Papoutsas cross roads. Papoutsas cross road to Zoopiysi along the eastern road.

Zoopiysi to Ayios Mamas and thence to the junction north of Trimiklini. Trimiklini to Karvounas cross roads, from the junction north of Trimiklini.
