In exercise of the powers vested in him by section 19 of the Streets and Buildings Regulation Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following regulations:—

1. These Regulations may be cited as the Streets and Buildings (Amendment) Regulations, 1956, and shall be read as one with the Streets and Buildings Regulations (hereinafter referred to as “the principal Regulations”).

2. Paragraph 2 of Regulation 62 of the principal Regulations is hereby amended by the deletion therefrom of the words “Councils of the Municipal Corporations of Nicosia, Limassol and Larnaca” (as set out in regulation 2 of the Streets and Buildings (Amendment) Regulations, 1954), and the substitution therefor of the words “Councils of the Municipal Corporations of Nicosia, Limassol, Larnaca and Famagusta”.

3. The Schedule to the principal Regulations is hereby amended by the deletion therefrom of Part II (as set out in Regulation 3 of the Streets and Buildings (Amendment) Regulations, 1954) and the substitution therefor of the following:—

“PART II.

Fees for permits in respect of domestic and public buildings in Nicosia, Limassol, Larnaca and Famagusta (in lieu of the fees set out in paragraph 2 (a) of Part I).
