THE STREETS AND BUILDINGS REGULATION LAW.

CAP. 165 AND LAWS 10 OF 1950, 44 OF 1954 AND 18 OF 1955.

NOTICE UNDER SECTION 14 (1).

In exercise of the powers vested in me by section 14 (1) of the Streets and Buildings Regulation Law, I, the Commissioner of Limassol as Chairman of the Improvement Board of Episkopi, the appropriate authority under section 3 (2) (b) of the aforesaid Law, do hereby, with the approval of the Governor, define the area described in the First Schedule hereto as a zone within which buildings for the special trades and industries specified in the Second Schedule hereto may not be erected.

FIRST SCHEDULE.

The area lying within the following boundaries that is to say :—

The boundary commences at the most northern point of plot No. 6 of the Government Survey Plan No. LVIII.4 and proceeds south-eastwards along the boundary of the said plot to the most southern point of plot No. 94 of the Government Survey Plan No. III.60 ; thence south-eastwards in a straight line to the south-western corner of plot No. 20 of the Government Survey Plan No. LVIII.4 ; thence south-eastwards along the southern boundary of the said plot to the south-eastern corner of the said plot ; thence south-eastwards along the boundaries of and including plot Nos. 27, 26, 25, 24 and 34 of the said plan, plots Nos. 90, 92, 93, 94 96 and 95 of the Government Survey Plan No. LVIII.5 to the south-eastern corner of the last mentioned plot ; thence south-eastwards along the southern boundary of plot No. 97 to the north-western corner of plot No. 125 of the said plan ; thence southwards in a straight line to the north-eastern corner of plot No. 131 of the said plan ; thence south-westwards along the boundary of and including the said plot and plots Nos. 18, 22 and 12 of the Government Survey Plan No. LVIII.12 to the most southern point of the last mentioned plot ; thence south-westwards in a straight line to the sea-shore ; thence north-westwards along the said sea-shore to the most western point of plot No. 52 of the Government Survey Plan No. LVIII.4 ; thence north-eastwards along the western boundary of the said plot and plots Nos. 3 and 6 of the said plan to the point of commencement, all which boundary of the said area is shown edged green on the Government Survey Map marked " Planning and Housing Department Plan No. LL/EP/1 " and deposited with the Commissioner's Office, Limassol.

SECOND SCHEDULE.

1. The warehousing of any kind of goods.
2. Any trade or business in which articles are manufactured, altered, cleaned, washed, repaired, ornamented, finished, packed, canned, adapted for sale, broken up or demolished or in which materials are transformed, including shipbuilding, and the generation, transformation of electricity and motive power of any kind which, by reason of any process carried on, machinery installed traffic, noise, vibration, smell, fume, smoke, soot, ash, dust or grit made, caused or produced is detrimental to the amenities of any area other than an industrial area.
