**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 11) 1956.**

ORDER MADE UNDER REGULATION 38A.

In exercise of the powers vested in him by regulation 38A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 11) 1956, His Excellency the Governor considering it necessary in the public interest so to do, hereby orders that the area set out in the Schedule hereto, be declared a danger area subject to the following conditions :—

The limits and extent of the area shall be demarcated by notices in English, Greek and Turkish put up at the point where each road or recognized track enters the area and on any prominent and accessible feature lying in the boundaries of the said area.

2. This Order may be cited as the Danger Areas (Famagusta District No. 2) Order, 1956, and shall come into effect on 1st October, 1956.

SCHEDULE.

That area within the Port limits of Famagusta, comprising all islands, reefs, causeways and harbour works, excluding the Nisi tou Jieri, which are separated by water from the mainland of Cyprus at high tide and appear on sheets XXXIII.4.3.III, XXXIII.4.3.IV, XXXIII.4.6.I, XXXIII.4.6.II, XXXIII.4.6.IV, XXXIII.5.4.I and XXXIII.5.4.III of the Government Survey plan, together with all that area covered by water at high tide bounded on the south and east by the causeway between Nisi tou Jieri and Nisin Megalon and by a line joining the southern end of the causeway to the most northerly point of plot 230, Block C, Ayios Nikolaos Quarter, on the north and west by a line joining the most southerly point of Nisin Megalon appearing on Sheet XXXIII.4.6.IV to the nearest point on the mainland.
