ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Famagusta District No. 4) Order, 1957.

2. No Turkish Cypriot born on or after the 1st January, 1930, shall be out of doors within the area prescribed in the First Schedule hereto between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 5th day of February, 1957, and shall remain in force until further notice.

Within the Municipal area of Famagusta.

SECOND SCHEDULE

Between 17.30 hours and 05.00 hours.

1. This Order may be cited as the Curfews (Limassol District No. 1) Order, 1957.

2. Within the area prescribed in the First Schedule hereto no Greek or Turkish Cypriot male person born between the 3rd February, 1930 and 3rd February, 1945, shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Limassol or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

This Order shall come into force on the 3rd day of February, 1957.

FIRST SCHEDULE.

Within the Municipal boundaries of Limassol town.

SECOND SCHEDULE.

From 05.30 hours on Sunday the 3rd February, 1957 until 05.00 hours on Monday the 4th February, 1957.
