DIRECTIONS GIVEN UNDER SECTION 15.

In exercise of the powers vested in me by section 15 of the Port Regulation Law, I, the Superintendent of Limassol Port, do hereby give the following directions :—

Save with my permission in writing, navigation by any vessel is prohibited within the area described in the Schedule hereto.

SCHEDULE.

The area within 600 yards of the Limassol shoreline between lines drawn at right angles to the shore from the K.E.O. jetty and the Municipal Baths.

THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)  
LAWS, 1950 AND 1953.

BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF KALAVASOS.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Kalavasos hereby make the following bye-laws :—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Kalavasos (Amendment) Bye-laws, 1957, and shall be read as one with the Villages (Administration and Improvement) Kalavasos Bye-laws, 1951 to 1956 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Kalavasos Bye-laws, 1951 to 1957.

2. The Second Schedule (Bye-law 177) to the principal Bye-laws is hereby amended by the deletion therefrom of items 7 and 8 and the substitution therefor of the following :—
