

No. 341.**THE SOIL CONSERVATION LAWS, 1952 AND 1956.****NOTICE UNDER SECTION 9.**

Pursuant to section 9 of the Soil Conservation Laws, 1952 and 1956, it is hereby notified that with the approval of the Governor, a Soil Conservation Division has been formed at Chatos village in respect of the area lying within the following boundaries, that is to say :—

The boundary commences at the north-western corner of plot No. 56 of the Government Survey Plan No. XIII.64, locality "Zeytin Kirach" and proceeds north-eastwards along the boundary of and including the said plot, plots Nos. 55, 52 (part) and 207 of the said plan, to the north-eastern corner of the last mentioned plot; thence southwards in a straight line to the south-eastern corner of plot No. 206 of the said plan; thence in a southerly and northerly direction along the boundary of and including the said plot, plots Nos. 204, 197, 198, 194, 193, 192, 184, 185, 186 (part), 211, 213, 214/2, 215 and 216/1 of the said plan, plots Nos. 219, 218, 217, 220 and 215 of the Government Survey Plan No. XIII.56, to the most northern point of the last mentioned plot, which point is on the boundary between the villages of Chatos and Knodhara; thence southwards along the said boundary to the south-eastern corner of plot No. 225 of the Government Survey Plan No. XIII.64, which corner is on a track leading from the village of Chatos to the village of Knodhara; thence south-westwards along the said track to the north-eastern corner of plot No. 158 of the said plan; thence in a southerly direction along the boundary of and including the said plot, plots Nos. 157, 156 and 144 of the said plan, plots Nos. 112, 113 and 117 of the Government Survey Plan No. XXII.8, to the south-eastern corner of the last mentioned plot, which corner is on the Nicosia-Lefkoniko main road; thence westwards along the said main road to its junction with a track (at a locality "Kireshtlik") leading to the village of Chatos; thence north-westwards along the said track to the most western point of plot No. 12/1 of the said plan, locality "Kizil Boghaz"; thence in a northerly direction along the boundary of and including the said plot, plots Nos. 12, 8 and 9 of the said plan, plots Nos. 128, 127, 123, 124, 130, 86 (part), 87, 88, 92/1, 92, 93, 73, 74, 75, 66, 68, 57 and 56 of the Government Survey Plan No. XIII.64 to the point of commencement, all which said area is shown edged in red on the Government Survey Plan signed by the Director of Agriculture, dated the 18th March, 1957, and deposited in his Office at Nicosia.

And that the Soil Conservation Scheme briefly set out in the Appendix hereto will be in operation within the aforesaid area.

APPENDIX.

Considerable levelling will be carried out for the filling of the gullies and also for the smoothing up of the land; some of the existing stone walls and an existing spillway will be reconstructed; some more flood control spillways will be constructed; and the irrigation channels will be cleared and re-arranged.

The total cost of the scheme has been estimated at approximately £14,000.
