In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, the following rules made by the Committee of the Irrigation Division of Linou, in the District of Nicosia, are published in the *Gazette*.

These Rules may be cited as the Irrigation Division of Linou (Amendment) Rules, 1957, and shall be read as one with the Irrigation Division of Linou Rules, 1936 to 1948 (hereinafter referred to as "the principal Rules"), and the principal Rules and these Rules may together be cited as the Irrigation Division of Linou Rules, 1936 to 1957.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "twenty-five shillings" and the substitution therefor of the words "three pounds".

THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAWS, 1949 AND 1954.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Law, 1949, the following rules made by the Committee of the Irrigation Association of Istinjo (Halassa Water) in the District of Paphos, are published in the *Gazette*.

IRRIGATION ASSOCIATION OF ISTINJO (HALASSA WATER).

Rules.

1. These rules may be cited as the Irrigation Association of Istinjo (Halassa Water) Rules, 1957.
2. In these rules, unless the context otherwise requires—
 - "Commissioner" means the Commissioner of the District of Paphos;
 - "Committee" means the Committee of the Irrigation Association;
 - "Irrigation Association" means the Irrigation Association of Istinjo (Halassa Water);
 - "Law" means the Irrigation (Private Water) Association Laws, 1949 and 1954;
 - "List" means the list of the names and residences of the proprietors and of the extent of the interest of each proprietor in the water, as finally settled in accordance with the provisions of section 11 of the Law;
 - "Works" means the irrigation works of the Irrigation Association;
 - "Water" means the water commonly known as "Halassa";
