BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION
OF LARNACA.

In exercise of the powers vested in them by the Municipal Corporations Law and otherwise, the Council of the Municipal Corporation of Larnaca hereby make the following bye-laws :—

1. These bye-laws may be cited as the Larnaca Municipal (Amendment) Bye-laws, 1957, and shall be read as one with the Larnaca Municipal Bye-laws, 1949 to 1956 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Larnaca) Bye-laws, 1949 to 1957.

2. Bye-law 15 of the principal Bye-laws is hereby amended by the insertion therein immediately after paragraph (2) of the following paragraph (3) :-

“(3) A rent not exceeding 100 mils per diem as determined by the Inspector shall be paid by every person using every space under Nos. 1 to 16 in the Municipal Market No. 1 for the sale of perishable goods”.

3. Paragraph 1 of bye-law 74 of the principal Bye-laws (as set out in the Municipal Corporation (Larnaca) (Amendment) Bye-laws (No. 2) of 1955) is hereby repealed and the following paragraph substituted therefor :—

" 1.—(a)—(i) for every bull, calf, camel, cow or ox not exceeding 20 okes in weight	300
(ii) if exceeding 20 okes in weight then in addition to the above fee, for every additional oke or part thereof	15
(b) for every goat or sheep	200
(c) for every kid slaughtered between the 1st November of any year to the 30th April of the following year	150
(d) for every kid slaughtered between the 1st May and the 31st October of any year	200
(e) for every lamb slaughtered between the 1st November of any year to the last day of February of the following year	150
(f) for every lamb slaughtered between the 1st March and the 31st October of any year	200
(g)—(i) for every pig not exceeding 10 okes in weight	150
(ii) for every pig exceeding 10 okes in weight but not exceeding 20 okes in weight	300
(iii) if exceeding 20 okes in weight, then in addition to the above fees for each additional oke or part thereof	15 "
