## THE CUSTOMS MANAGEMENT LAWS, 1954 TO 1957.

## ORDER IN COUNCIL No. 2951

MADE UNDER SECTION 42.

In exercise of the powers vested in him by section 42 of the Customs Management Laws, 1954 to 1957, the Governor's Deputy, with the advice of the Executive Council, has been pleased to order as follows :—

This Order may be cited as the Customs Management (Banderoles) (Amendment) Order, 1957, and shall be read as one with the Customs Management (Banderoles) Order, 1954 (hereinafter referred to as "the principal Order") and this Order may together be cited as the Customs Management (Banderoles) Orders, 1954 and 1957.

## THE PUBLIC HEALTH (VILLAGES) LAW.

CAP. 142.

## ORDER IN COUNCIL No. 2952

MADE UNDER SECTION 10.

*Authority to the Village Health Commission of Trakhonas (Nicosia District) to contract a loan.*

In exercise of the powers vested in him by section 10 of the Public Health (Villages) Law, the Governor's Deputy, with the advice of the Executive Council, has been pleased to order as follows :—

1. The Village Health Commission of Trakhonas (Nicosia District) (hereinafter referred to as "the Village Health Commission") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender") the sum of three thousand nine hundred and fifty pounds (£3,950) at a rate of interest not exceeding four and a quarter per centum ( $4\frac{1}{4}\%$ ) per annum, subject to the following terms and conditions :—

- (a) the sum borrowed shall be repayable by the Village Health Commission to the Lender in fifteen equal annual instalments (comprising sinking fund and interest);
- (b) the Village Health Commission shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate;
- (c) the sum borrowed shall be utilized by the Village Health Commission for the erection of a slaughter-house and a meat market,
