**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 19th October, 1955, and published in Supplement No. 3 to the *Gazette* of the 20th October, 1955, under Notification No. 638 (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Pano Platres (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 297, 1164 and 393 published in Supplement No. 3 to the *Gazettes* of the 12th April, 1956, 29th November, 1956 and 11th April, 1957, respectively, the Order was extended for further periods of six months up to the 18th October, 1957 ;
