**No. 920. NOTIFICATION UNDER THE TREE PLANTING
VILLAGE AREAS LAW.**

SILIKOU (LIMASSOL) FUND.

The money in the Fund shall be utilized for works of public utility in the village of Silikou.

**No. 921. THE AGRICULTURAL PRODUCE (EXPORT)
REGULATIONS, 1956.**

NOTICE BY THE DIRECTOR OF COMMERCE AND INDUSTRY.

It is hereby prescribed in accordance with the provisions of Regulation 4 of the above Regulations that the written notice to be given by any person who intends to export any produce shall be in the following form :—

"The Agricultural Produce (Export) Regulations.

**APPLICATION FOR INSPECTION OF AGRICULTURAL PRODUCE
(Regulation 4.)**

To the Officer of the Commerce and Industry Department i/c of.....

This is to inform you that I/we shall be exporting Agricultural produce, particulars of which are given below, and therefore I/we request that the produce be duly inspected in (a) my/our Packing House/the Produce Inspection Shed.

2. I/we declare that the provisions of the Agricultural Produce (Export) Laws and the Regulations governing the export of Agricultural produce are known to me/us and to the best of my/our knowledge, the produce presented for inspection (b) *is wholly the product of Cyprus* and conforms to the Regulations for the time being in force.
