THE AGRICULTURAL PRODUCE (EXPORT) LAW.
CAP. 39 AND LAW 50 OF 1954.

AUTHORISATION AS PRODUCE INSPECTORS.

By virtue of the powers vested in me by section 2 of the Agricultural Produce (Export) Law, I, the Director of Commerce and Industry, hereby appoint the persons whose names appear in the Schedule hereto to be "produce inspectors" for the purposes of the said Law, until further notice, in respect of potatoes and carrots.

**BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL
CORPORATION OF MORPHOU.**

In exercise of the powers vested in them by the Municipal Corporations Law, and otherwise, the Council of the Municipal Corporation of Morphou hereby make the following Bye-laws :—

1. These Bye-laws may be cited as the Morphou Municipal (Amendment) Bye-laws, 1941 to 1957 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these Bye-laws may together be cited as the Morphou Municipal Bye-laws, 1941 to 1958.
