THE SUPPLIES AND SERVICES (TRANSITIONAL
 POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE
 REGULATION 64.

Whereas by Order dated the 29th May, 1956, and published in Supplement No. 3 to the *Gazette* of the 30th May, 1956, under Notification No. 438 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order situated in the "Karaios" locality of Ayios Loukas Quarter, Famagusta (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months;

And whereas by virtue of Notifications Nos. 1165, 498 and 962 published in Supplement No. 3 to the *Gazettes* of the 29th November, 1956, 2nd May, 1957 and 31st October, 1957, respectively, the Order was extended for further periods of six months up to the 28th May, 1958;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months:
