**No. 428. THE TRADE UNIONS LAW.**  
**CAP. 172 AND LAWS 15 OF 1952 AND 3 OF 1954.**

**REGULATIONS MADE UNDER SECTION 52.**

In exercise of the powers vested in him by section 52 of the Trade Unions Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following regulations :—

1. These Regulations may be cited as the Trade Unions (Amendment) Regulations, 1958, and shall be read as one with the Trade Unions Regulations (hereinafter referred to as "the principal Regulations").

2. Regulation 27 of the principal Regulations is hereby amended by the substitution for the words "shall be payable in cash to the District Treasury of the District within which the registered office of the trade union is situated" (lines 3 and 4) of the words "shall be paid in such manner as the Registrar may from time to time direct".

3. The First Appendix to the principal Regulations is hereby amended by the deletion therefrom of Form No. 1 and the substitution therefor of the following Form :—
