THE POLICE LAW, 1958.

REGULATIONS MADE UNDER SECTION 10.

In exercise of the powers vested in me by section 10 of the Police Law, 1958, I, the Chief Constable, with the approval of the Governor, do hereby make the following regulations :—

1. These Regulations may be cited as the Police (Discipline) (Amendment) Regulations, 1958, and shall be read as one with the Police (Discipline) Regulations, 1958 (hereinafter referred to as "the principal Regulations").

2. Paragraph (2) of regulation 8 of the principal Regulations is hereby amended as follows :—

(a) by the substitution for the words "Assistant Superintendent", which occur in the second line thereof, of the word "Inspector";

(b) by the substitution for the words "Assistant Superintendent", which occur in the second line of paragraph (i) of the proviso thereto, of the word "Inspector".

3. Paragraph (4) of regulation 18 of the principal Regulations is hereby amended by the substitution for the words "All cases heard by a Gazetted Officer" (line 1) of the words "All cases in which a member of the Force has been found guilty of an offence against the Discipline Code and which have been heard by a Gazetted Officer".
