

THE ANTIQUITIES LAW.  
CAP. 43.

ORDER IN COUNCIL No. 3031  
MADE UNDER SECTION 6 (1).

In exercise of the powers vested in him by section 6 (1) of the Antiquities Law, Cap. 43, His Excellency the Governor, on the recommendation of the Director of Antiquities and with the advice of the Executive Council, hereby declares the buildings and sites described in the Schedule hereto to be ancient monuments and hereby declares that the said Ancient Monuments shall be added to the First Schedule of the said Law under the appropriate District headings and with the item numbers respectively assigned to them in the first column of the Schedule hereto.

2. The notice of the Director of Antiquities under section 6 (2) of the Antiquities Law, Cap. 43, with regard to the said buildings and sites was published in Supplement No. 3 to the *Gazette* of the 5th December, 1957, under No. 1071.
