

**No. 903. THE EMERGENCY POWERS (PUBLIC SAFETY
AND ORDER) REGULATIONS, 1955 TO (No. 5) 1958.**

ORDER MADE BY THE GOVERNOR UNDER REGULATION 41 (1).

In exercise of the powers vested in me by Regulation 41 (1) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Governor, do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Publication of Casualties) (Amendment) Order, 1958, and shall be read as one with the Emergency Powers (Publication of Casualties) Order, 1956 (hereinafter referred to as “the principal Order”) and the principal Order and this Order may together be cited as the Emergency Powers (Publication of Casualties) Orders, 1956 and 1958.

2. Paragraph 2 of the principal Order is hereby amended by deleting sub-paragraph (b) thereof and by substituting therefor the following sub-paragraph to be lettered “(b)” :—

“(b) of the name, appointment or department of any expatriate officer in the service of the Crown.”.

AMENDMENT OF ORDER MADE UNDER SECTION 124 (1).

Whereas by Order in Council No. 2997 published under Notification No. 91 in Supplement No. 3 to the *Gazette* of the 20th February, 1958 (hereinafter referred to as “the Order”) authority was given to the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Limassol to borrow from the Government the sum of six thousand five hundred pounds (£6,500), subject to the terms and conditions specified therein ;

And whereas it is found desirable to amend the Order :

Now, therefore, in exercise of the powers vested in him by section 124 (1) of the Municipal Corporations Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. Sub-paragraph (g) of paragraph 1 of the Order is hereby amended by the substitution for the figures and word “31st July, 1958” occurring therein of the figures and word “31st December, 1958”.

2. Sub-paragraphs (a) and (h) of paragraph 1 of the Order and the two provisoes to sub-paragraph (h) are hereby amended by the substitution for the figures and word “31st May, 1958” occurring therein of the figures and word “31st October, 1958”.
