**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 22nd June, 1956, and published in Supplement No. 3 to the *Gazette* of the 28th June, 1956, under Notification No. 595 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Yermasoyia village (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 1165, 577 and 1049 published in Supplement No. 3 to the *Gazettes* of the 29th November, 1956, 6th June, 1957, and 28th November, 1957, respectively, the Order was extended for further periods of six months up to the 21st June, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor has authorized the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 22nd June, 1958.

And whereas by virtue of Notifications Nos. 796, 73, 738 and 42 published in Supplement No. 3 to the *Gazettes* of the 23rd August, 1956, 31st January, 1957, 1st August 1957 and 30th January, 1958, respectively, the Order was extended for further periods of six months up to the 1st August, 1958 :
