ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Famagusta District)(No. 47) Order, 1958.

2. No Greek Cypriot within the area prescribed in the First Schedule hereto born between the 1st January, 1932 and the 1st January, 1944, shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

3. This Order shall come into force on the 13th October, 1958, and shall remain in force until further notice.

The Municipal area of Famagusta Town.

SECOND SCHEDULE.

From 1700 hours till 0500 hours nightly.

1. This Order may be cited as the Curfews (Famagusta District) (No. 53) Order, 1958.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Famagusta or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces or the Cyprus Police Force.

3. This Order shall come into force on the 25th October, 1958.

The village area of Yialousa.

SECOND SCHEDULE.

From 1500 hours on 25th October, 1958, till 1800 hours on 27th October, 1958.
