THE EMERGENCY POWERS ORDERS IN COUNCIL, 1939 AND 1956.

REGULATIONS MADE BY THE GOVERNOR UNDER SECTION 6.

HUGH FOOT,

Governor.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1956, I, the Governor, do hereby make the following regulations :—

1. These Regulations may be cited as the Emergency Powers (Amendment of the Village Authorities Law) Regulations, 1958.

2. During the continuance in force of these Regulations, the Village Authorities Law shall be read and construed as if sub-section (1) of section 6A thereof (as set out in section 3 of Law 60 of 1955 and as amended by Law 30 of 1957) were amended by the substitution for the words " shall continue to hold office as mukhtar or aza until the 30th day of November, 1958 ", occurring at the end thereof, of the words " or appointed to such office subsequent to that date, shall continue to hold office as mukhtar or aza during the continuance in force of this section ".
