

No. 231. THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 5th October, 1956, and published under Public Instrument No. 965 of 1956 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Eylenja (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 398 of 1957, 883 of 1957, 140 of 1958 and 1015 of 1958, the Order was extended for further periods of six months up to the 8th April, 1959.

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorised the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 9th April, 1959.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 3rd October, 1957, and published under Public Instrument No. 915 of 1957 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Ayios Andreas Quarter, Nicosia (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Public Instruments Nos. 229 of 1958 and 1012 of 1958, the Order was extended for further periods of six months up to the 2nd April, 1959.

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1958), His Excellency the Governor has authorised the use of the said land for military purposes subject to the restrictions and conditions laid down in the Order for a further period of six months as from the 3rd April, 1959.
