No. 547. THE REGISTRATION OF ELECTORS LAW, 1959.

ORDER MADE UNDER SECTION 2 (3).

In exercise of the powers vested in him by sub-section (3) of section 2 of the Registration of Electors Law, 1959, His Excellency the Governor has been pleased to order as follows :—

1. This Order may be cited as the Registration of Electors (Individual Options) Order, 1959.

2. The persons whose names and particulars are set out in the First Schedule hereto, having declared in writing to the Governor, under the provisions of sub-section (3) of section 2 of the Registration of Electors Law, 1959, that they fulfil each of the requirements (i) to (iii) specified in the said sub-section (3) of section 2, and that they desire to be registered in a Greek Register of electors, the Governor, being satisfied of all the matters contained in such declarations, has been pleased to declare, and it is hereby declared, that such persons shall be registered in a Greek Register of electors.

3. The persons whose names and particulars are set out in the Second Schedule hereto, having declared in writing to the Governor, under the provisions of sub-section (3) of section 2 of the Registration of Electors Law, 1959, that they fulfil each of the requirements (i) to (iii) specified in the said sub-section (3) of section 2, and that they desire to be registered in a Turkish Register of electors, the Governor, being satisfied of all the matters contained in such declarations, has been pleased to declare, and it is hereby declared, that such persons shall be registered in a Turkish Register of electors.
