**THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.
CAP. 311 AND LAWS 28 OF 1951, 12 OF 1952 AND 13 OF 1957.**

(SECTION 12 (2)).

Notice is hereby given that the immovable property, as hereinafter, is required by the Water Commission of Angolemi village, in connection with a scheme for the supply and/or maintenance of a supply of water for the domestic purposes of the inhabitants of the said village under the provisions of the Water (Domestic Purposes) Village Supplies Law, Cap. 311.

Any person claiming to have any right or interest in the immovable property to which this notice relates, who objects to the acquisition of any such property, is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.
