ORDER IN COUNCIL No. 3125

MADE UNDER SECTION 12 (2).

Whereas by sub-section (2) of section 12 of the Dangerous Drugs Law, 1956, power is conferred upon the Governor by Order in Council to declare that Part III of the Law shall apply to any drug of whatever kind in the same manner as it applies to the drugs mentioned in sub-section (1) of the said section 12 if it appears to the Governor that the drug is, or is likely to be, productive, if improperly used, of ill effects substantially of the same character or nature as, or analogous to, those produced by morphine or cocaine, or is capable of being converted into a substance which is, or is likely to be, productive if improperly used, of such effects ;

And whereas it appears to the Governor that the drugs specified in the Schedule to this Order are, or are likely to be, productive if improperly used, of effects substantially of the same character or nature as, or analogous to, those produced by morphine or cocaine:

Now, therefore, in exercise of the powers conferred upon him by sub-section (2) of section 12 of the Dangerous Drugs Law, 1956, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order and declare as follows:—

1. This Order may be cited as the Dangerous Drugs (Application of Law) Order, 1960.

2. Part III of the Dangerous Drugs Law, 1956, shall apply to the drugs specified in the Schedule to this Order in the same manner as the said Part III applies to the drugs mentioned in sub-section (1) of section 12 of the said Law.

SCHEDULE.

1. Benzethine (Ethyl 1 (2-benzyloxyethyl)-4-phenylpiperidine-4-carboxylate), its salts and any preparation, admixture, extract or other substance containing any proportion of benzethine.

2. Dimenoxadole (2-dimethylaminoethyl-2-ethoxy 2: 2-diphenylacetate), its salts and any preparation, admixture, extract or other substance containing any proportion of dimenoxadole.

3. Furethine (Ethyl 1 (2-tetrahydrofurfuryloxyethyl)-4-phenylpiperidine-4-carboxylate), its salts and any preparation, admixture, extract or other substance containing any proportion of furethine.

4. Norcodeine, its salts and any preparation, admixture, extract or other substance containing any proportion of norcodeine.

5. Normorphine, its salts and any preparation, admixture, extract or other substance containing any proportion of normorphine.

6. Phenazocine 2'-hydroxy-5: 9-dimethyl-2-(2-phenylethyl)-6: 7 benzomorphan), its salts and any preparation, admixture, extract or other substance, containing any proportion of 2'-hydroxy-5: 9-dimethyl-2-(2-phenylethyl)-6: 7-benzomorphan.
