

No. 122.**THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW.**

CAP. 311 AND LAWS 28 OF 1951, 12 OF 1952 AND 13 OF 1957.

NOTIFICATION UNDER SECTION 12 (4).

Whereas immovable property is required by the Water Commission of Angolemi in connection with a scheme for the supply and/or maintenance of a supply, of water for the domestic purposes of the inhabitants of the said village ;

And whereas the Commissioner of Nicosia and Kyrenia, in compliance with section 12 (2) of the Water (Domestic Purposes) Village Supplies Law, by notice published as Public Instrument No. 5 of 1960, and posted at a conspicuous place in the village concerned, gave a description and particulars of the immovable property required as aforesaid (hereinafter referred to as "the immovable property") and required any person claiming any right or interest therein to submit his claim with the necessary evidence in support thereof within the period therein set out ;

And whereas the Commissioner of Nicosia and Kyrenia, at the expiration of the period set out in the aforesaid notice, forwarded to the Governor two plans of the immovable property, together with particulars as regards its owner, description and estimated value ;

And whereas the Governor has approved the plan submitted and considers it expedient, having regard to all the circumstances, that the Water Commission of Angolemi should be permitted to acquire the immovable property:

Now, therefore, in exercise of the powers vested in him by section 12 (4) of the Water (Domestic Purposes) Village Supplies Law, His Excellency the Governor has been pleased to sanction the acquisition of the immovable property.

No. 123.**THE LAND ACQUISITION LAW.**

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

AMENDMENT OF NOTICE UNDER SECTION 6.

The notice made on the 5th January, 1960, and published as Public Instrument No. 11 of 1960, is hereby amended as follows :—

By the deletion of the words " Her Majesty's Secretary of State for Air " from paragraph 3 of the said notice and the substitution therefor of the words " The Governor ".

2. The period mentioned in paragraph 2 of the said notice has, with the approval of the Governor, been extended for a further abridged period of ten days commencing from the date of publication of this notice.
