**THE IRRIGATION DIVISIONS (VILLAGES) LAW.
CAP. 111.**

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, Cap. 111, the following Rules made by the Committee of the Irrigation Division of Nata-Kholetria in the District of Paphos are published in the *Gazette*.

IRRIGATION DIVISION OF NATA-KHOLETRIA.

Rules.

These rules may be cited as the Irrigation Division of Nata-Kholetria P.I.: (Amendment) Rules, 1960, and shall be read as one with the Irrigation Division of Nata-Kholetria Rules, 1945 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Irrigation Division of Nata-Kholetria Rules, 1945 and 1960. 165/1945.

2. Rule 4 (3) of the principal Rules is hereby amended by the deletion therefrom of the words "the Treasurer shall be unpaid" and the substitution therefor of the words "the Treasurer shall be paid 5% on the amounts collected by him in respect of the yearly assessments".

THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAWS, 1949 AND 1954.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Laws, 1949 and 1954, the following rules made by the Committee of the Irrigation Association of Pano Koutraphas ("Tsifliki Water"), in the District of Nicosia, are published in the *Gazette*.

IRRIGATION ASSOCIATION OF PANO KOUTRAPHAS ("TSIFLIKI WATER").

Rules.

1. These rules may be cited as the Irrigation Association of Pano Koutraphas ("Tsifliki Water") Rules, 1960.

2. In these rules, unless the context otherwise requires—

 "Commissioner" means the Commissioner of the District of Nicosia;

 "Committee" means the Committee of the Irrigation Association;

 "Irrigation Association" means the Irrigation Association of Pano Koutraphas ("Tsifliki Water");

 "Law" means the Irrigation (Private Water) Association Laws, 1949 and 1954;

 "List" means the list of the names and residences of the proprietors and of the extent of the interest of each proprietor in the water, as finally settled in accordance with the provisions of section 11 of the Law;

 "Water" means the water commonly known as "Tsifliki Water";

 "Works" means the irrigation works of the Irrigation Association;

3. The present Committee shall hold office for a period of three years beginning on the 15th May, 1960. The election of each subsequent Committee shall take place in the manner hereinafter provided every third year in the first week of the month of April and it shall hold office for a period of three years from the date of the expiration of the period of office of the previous Committee.

4.—(1) The Commissioner shall, not less than one month before the holding of the meeting as in rule 3 provided, cause a written notice thereof to be—

 (a) published in a newspaper or newspapers; and

 (b) posted in a conspicuous place in the town, village or quarter in which the water is situate.

(2) All expenses connected with the notices shall be paid for from the funds of the Irrigation Association.

5.—(1) The Commissioner shall preside at every meeting so convened and if any question is raised as to the right of a person to attend thereat or to vote, the Commissioner may there and then make such enquiry as he may deem requisite and declare whether such person has a right to attend or to vote or not and the decision so made shall be final; and an entry shall be made in the minutes of the meeting of any such question and of the decision thereon.

(2) No business shall be transacted at any such meeting and no decision shall be taken thereat, unless more than one-half of the aggregate number of the proprietors are present in person or are represented by a proxy properly appointed by an instrument signed in the presence of and
