THE IRRIGATION DIVISIONS (VILLAGES) LAW.

CAP. 111 AND LAWS 7 OF 1949 AND 8 OF 1956.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Law, the following Rules made by the Committee of the Irrigation Division of Pano Pyrgos, Kato Pyrgos and Piyenia "Katouris River", in the District of Nicosia, are published in the *Gazette*.

IRRIGATION DIVISION OF PANO PYRGOS, KATO PYRGOS AND

These Rules may be cited as the Irrigation Division of Pano Pyrgos, Kato Pyrgos and Piyenia "Katouris River" (Amendment) Rules, 1960, and shall be read as one with the Irrigation Division of Pano Pyrgos, Kato Pyrgos and Piyenia "Katouris River" Rules 1953 (hereinafter referred to as the "Principal Rules") and the Principal Rules and these Rules may together be cited as the Irrigation Division of Pano Pyrgos, Kato Pyrgos and Piyenia "Katouris River" Rules 1953 and 1960.

2. Rule 4 (3) of the Principal Rules is hereby deleted and substituted by the following Rule :—

"The Treasurer shall receive a remuneration of three per centum of all rates and charges collected by him as in paragraph (1) hereof: Provided that he shall be paid such of his out of pocket expenses as may be sanctioned by the Committee".

3. Rule 15 of the Principal Rules is hereby deleted and substituted by the following Rule :—

"The Committee shall distribute the water from time to time to every proprietor appearing on the list prepared under Rule 5 in proportion to the number of donums of land to be irrigated by each proprietor having due regard to the quantity of water available".
