An Act to amend legislation relating to agricultural and veterinary chemicals, and for related purposes

[Assented to 23 June 2004]

The Parliament of Australia enacts:

1 Short title

This Act may be cited as the *Agricultural and Veterinary Chemicals Legislation Amendment (Name Change) Act 2004*.

2 Commencement

- (1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.
