1. pants. 3. pants. Pievienošanās paziņojumi stājas spēkā to pēdējā paraksta datumā, un Ārlietu ministrija par to paziņo oficiālajā izdevumā "Latvijas Vēstnesis".

4. pants. Līdz ar likumu izsludināmi Pievienošanās paziņojumi angļu valodā un to tulkojumi latviešu valodā.

HAVING DECIDED to broaden its participation in NATO's overall strategic communications transformation efforts; and

DESIRING to join the current Participants of the NATO StratCom COE as of 1 January 2019 and providing the personnel for post No DCE 008 (Senior Advisor at the Doctrine, Concept and Experimentation Branch).

ELECTS to participate as of 1 January 2019 in the Memorandum of Understanding among the Ministry of Defence of the Republic of Latvia, the Department of the National Defence of Canada, the Ministry of Defence of the Republic of Estonia, the Federal Ministry of Defence of the Federal Republic of Germany, the Ministry of Defence of the Italian Republic, the Ministry of National Defence of the Republic of Lithuania, the Ministry of Defence of the Kingdom of the Netherlands, the Minister of National Defence of the Republic of Poland, the Ministry of Defence of the Slovak Republic and the Ministry of Defence of the United Kingdom of Great Britain and Northern Ireland concerning the Establishment, Administration and Operation of the NATO StratCom COE, which came into effect on 1 July 2014 (NATO StratCom COE Operational MOU).

DECIDES to contribute its share to the annual budget starting with fiscal year 2019.

DECIDES to respect the

Technical Arrangement between the Swedish Civil Contingencies Agency and the Ministry of Defence of the Republic of Latvia, the Ministry of Defence of the Republic of Estonia, the Federal Ministry of Defence of the Federal Republic of Germany, the Ministry of Defence of the Italian Republic, the Ministry of National Defence of the Republic of Lithuania, the Minister of National Defence of the Poland, the Ministry of Defence of the United Kingdom of Great Britain and Northern Ireland, the Ministry of Defence of the Kingdom of the Netherlands regarding contributions of the Swedish Civil Contingencies Agency to the NATO Strategic Communications Centre of Excellence.

NOTING THAT without prejudice to the rights and obligations under the North Atlantic Treaty, the NATO SOFA, and the Paris Protocol, the Ministry of Foreign Affairs of Denmark understands that neither the NATO StratCom COE Operational MoU, nor the joining thereto by the Ministry of Foreign Affairs of Denmark, creates any rights or obligations under international law.
