## AKTA KASTAM 1967

## PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 4) 2011

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 4) 2011**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2012.

2. Perintah Kastam (Larangan Mengenai Import) 2008 [P.U. (A) 86/2008], yang disebut “Perintah ibu” dalam Perintah ini dipinda dalam Jadual Pertama—

(b) dengan memasukkan selepas butiran 17 butiran yang berikut:
