The Society for the Prevention of Cruelty to Animals Ordinance, 1962 (East Pakistan Ordinance)

(Ordinance NO. XV OF 1962)

An Ordinance for the constitution of the Bangladesh Society for the Prevention of Cruelty to Animals.¹

WHEREAS it is expedient to constitute a [* * *] Society for the Prevention of Cruelty to Animals, for the purpose and in the manner hereinafter appearing;

NOW, THEREFORE, in pursuance of the Presidential Proclamation of the seventh day of October, 1958, and in exercise of all powers enabling him in that behalf, the Governor is pleased to make and promulgate the following Ordinance, namely:-

Short title, 1. (1) This Ordinance may be called the ²[* * *] Society for the Prevention **extent and** of Cruelty to Animals Ordinance, 1962.

(2) It extends to the whole of Bangladesh.

(3) It shall come into force at once.

Definitions 2. In this Ordinance, unless there is anything repugnant in the subject or context,-

(a) "animal" means any domestic or captured animal except poultry;

(b) "Branch Society" means the Branch of the ${}^{3}[* * *]$ Society for the Prevention of Cruelty to Animals for a district constituted under section 11; and

(c) "Society" means the ⁴[* * *] Society for the Prevention of Cruelty to Animals constituted under section 3.

Constitution	3. (1) There shall be constituted a Society to be known as "the 6 [* * *]

Prevention(2) 7[The President of the People's Republic of Bangladesh] shall be the
Chairman of the Society and the first members thereof shall be appointed
either by name or by office by the Government.
 - (3) The headquarters of the Society shall be at Dacca.
 - Incorporation 4. The first members of the Society and all persons who may hereafter become members thereof so long as they continue so to be, shall be a body corporate under the name of the ⁸[* * *] Society for the Prevention of Cruelty to Animals, and the said body shall have perpetual succession and a common seal with powers to hold and acquire property, movable or immovable, and shall sue and be sued by the said name.

Functions5. Subject to the provisions of this Ordinance, and of the Bengal Cruelty toof theAnimals Act, 1920, the functions of the Society shall include,

(a) the exercise of such powers as may be delegated to it under section 30 of the Bengal Cruelty to Animals Act, 1920;

(b) the arrangement for the proper treatment and care of animals;

(c) the education of the general public in the proper care, treatment and destruction of animals; and

(d) the exercise of such powers and performance of such duties as may be prescribed by rules.

Appointment of
 Executive
 Committee
 6. (1) Until such time as an Executive Committee of the Society is constituted in accordance with the regulations made under section 7, the Executive Committee shall consist of such persons from among the members of the Society as may be nominated by the Government.

(2) The Government may nominate as office $T^{\frac{1}{4}}$ -bearers of the first Executive Committee such persons as it may select for the purpose:

Provided that the Government may reconstitute the first Executive Committee as and when it is deemed necessary.

 7. The first Executive Committee shall, subject to the previous approval of the Government, make regulations for the management, control and procedure of the Society. Such regulations may, among other matters, provide for the following, namely:-
 - (a) the conditions of membership of the Society;
 - (b) the constitution and functions of the Executive Committee; and

(c) the regulation of the procedure generally of the Society and the Executive Committee.

- **Fund** 9. (1) There shall be a fund to be known as the Society Fund which shall vest in and be administered by the Society.

(a) grants and subsidies from Government, Local Authorities and other bodies;

(b) donations from the public;
