Cabinet makes the following Regulations under section 36 of the Naoero National Anthem Emblem and Flag Protection Act 2018:

### 1 Citation

These Regulations may be cited as the Naoero National Anthem Emblem and Flag Protection Regulations 2019.

### 2 Commencement

These Regulations come into effect on the day they are notified in the Gazette.

### 3 Application for use of National Anthem Emblem or Flag

For the purposes of sections 6, 9, 11 and 20 of the Act, the prescribed form for an application for the use of the National Anthem, Emblem or Flag is set out in Form 1 in Schedule 1.

### 4 Particulars required

A person applying to the Minister for approval to use the National Anthem, Emblem or Flag shall provide:

- (a) surname and forenames;
- (b) name of firm, institution, corporation or group person is applying on behalf of;
- (c) usual residential address;
- (d) correspondence address, if different from address of the business;
- (e) purpose of use of the National Anthem, Emblem or Flag;
- (f) a certified copy of the business licence under the Business Licences Act 2017 if applicable;
- (g) a certified copy of certificate of incorporation or partnership if applicable; and
- (h) an undertaking to comply with the provisions of the Act in relation to the protection of the National Anthem, Emblem and Flag.

#### 5 Form of approval

Where the Minister approves an application for the use of the National Anthem, Emblem or Flag, the Secretary to Cabinet shall issue an approval under the hand of the Minister in accordance with Form 2 of Schedule 1 with any necessary conditions.

# 6 Register of approved users

A register of applications and approved users shall be kept by the Secretary to Cabinet as set out in Form 3 of Schedule 1.

### 7 Application fees

The prescribed fees to be paid for the purposes of the Act are set out in Schedule 2.
