DIVISION I - GENERAL PROVISIONS.

§1. Definitions.

As used in this Act, unless the context otherwise requires, the term:

- (1) **"business"** includes every trade, occupation and profession, the holding or ownership of property and any other activity for profit;
- (2) "certificate" means a certificate of partnership existence under section 29 of this Act, a certificate of dissociation under section 53 of this Act, a certificate of dissolution under section 59 of this Act, an amendment or cancellation of any of the foregoing under section 5 of this division, a certificate of correction and a corrected certificate under section 15 of this division, a certificate of conversion to partnership under section 62 of this Act, a certificate of merger or consolidation under section 63 of this Act, a certificate of partnership
